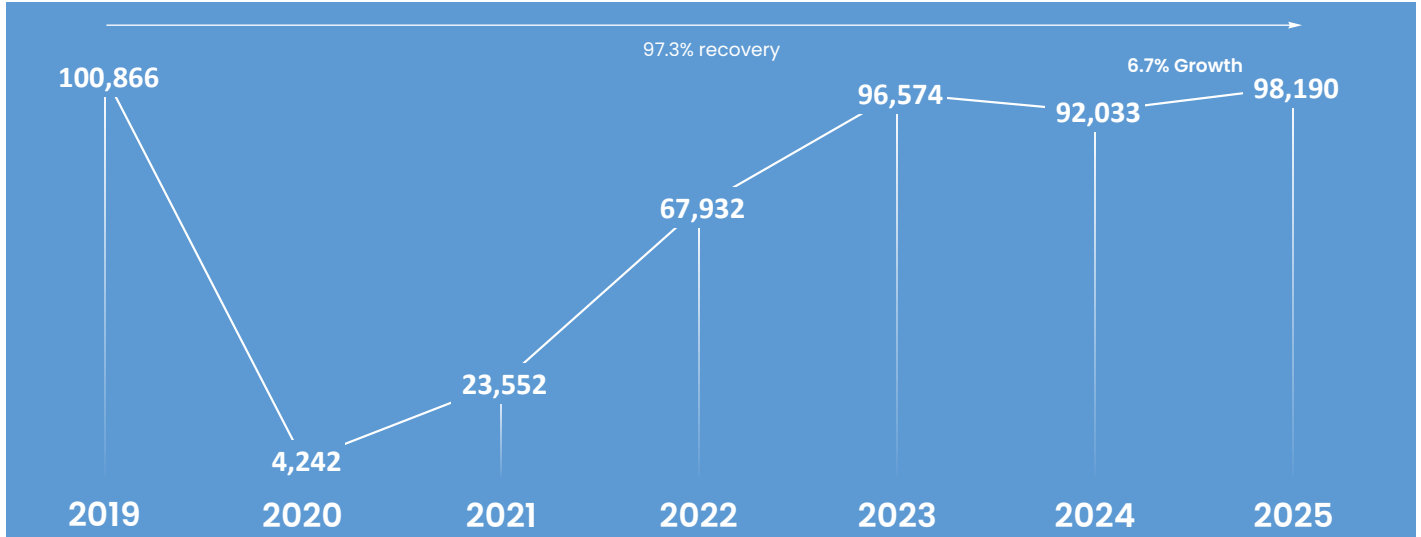

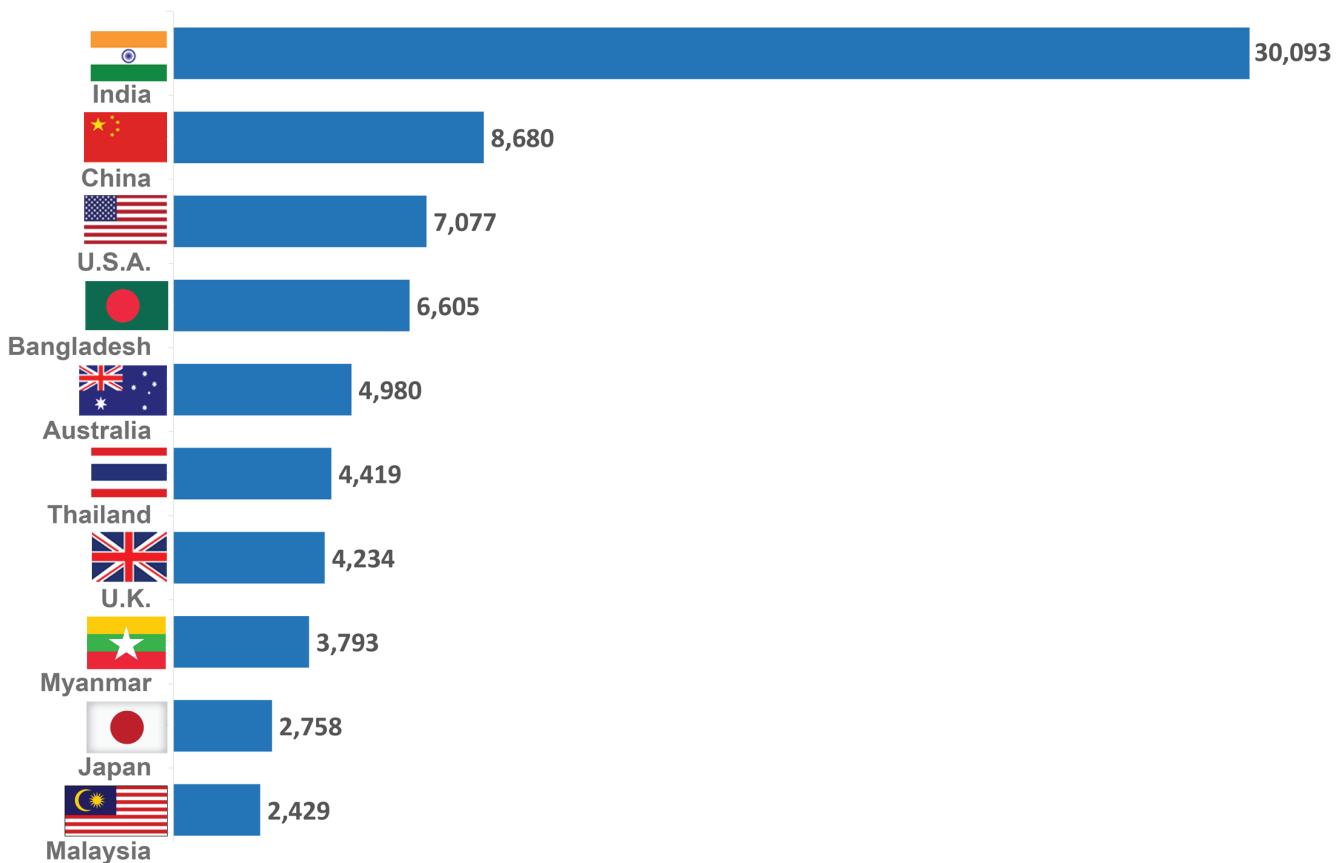

Top 10 Source Market Countries (DECEMBER)



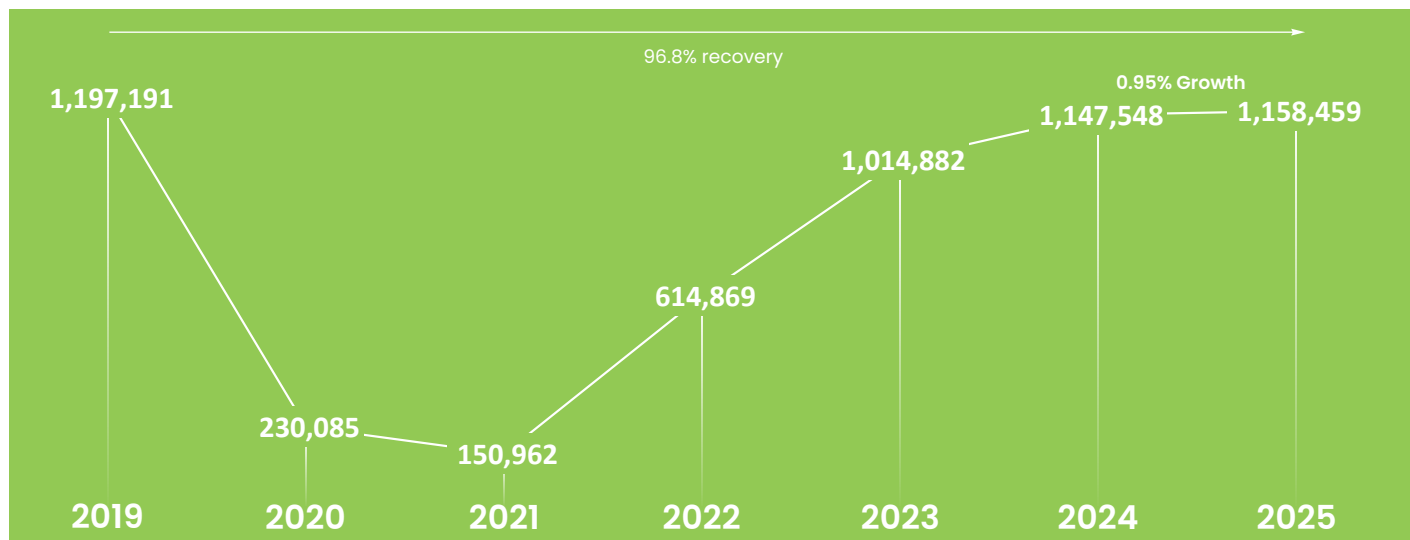

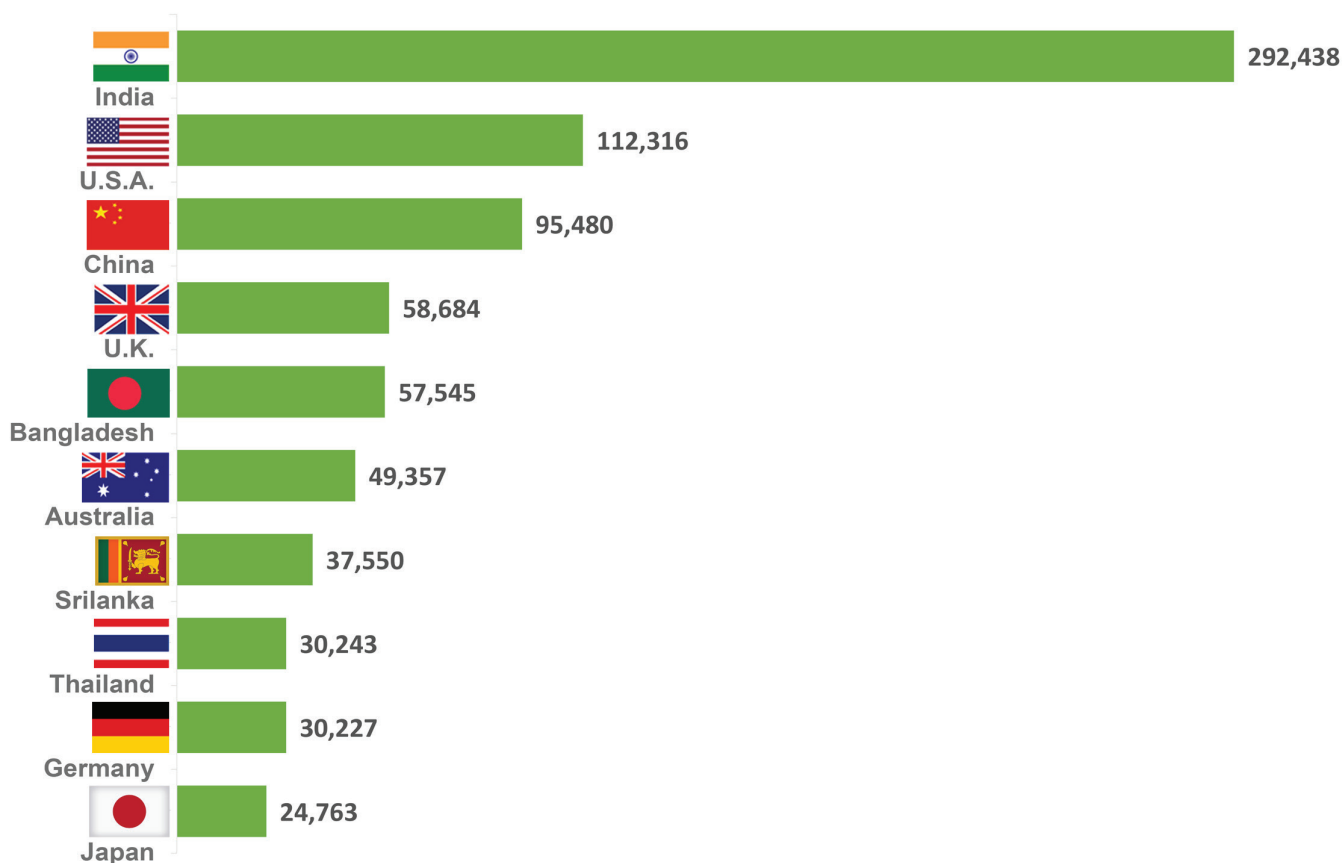

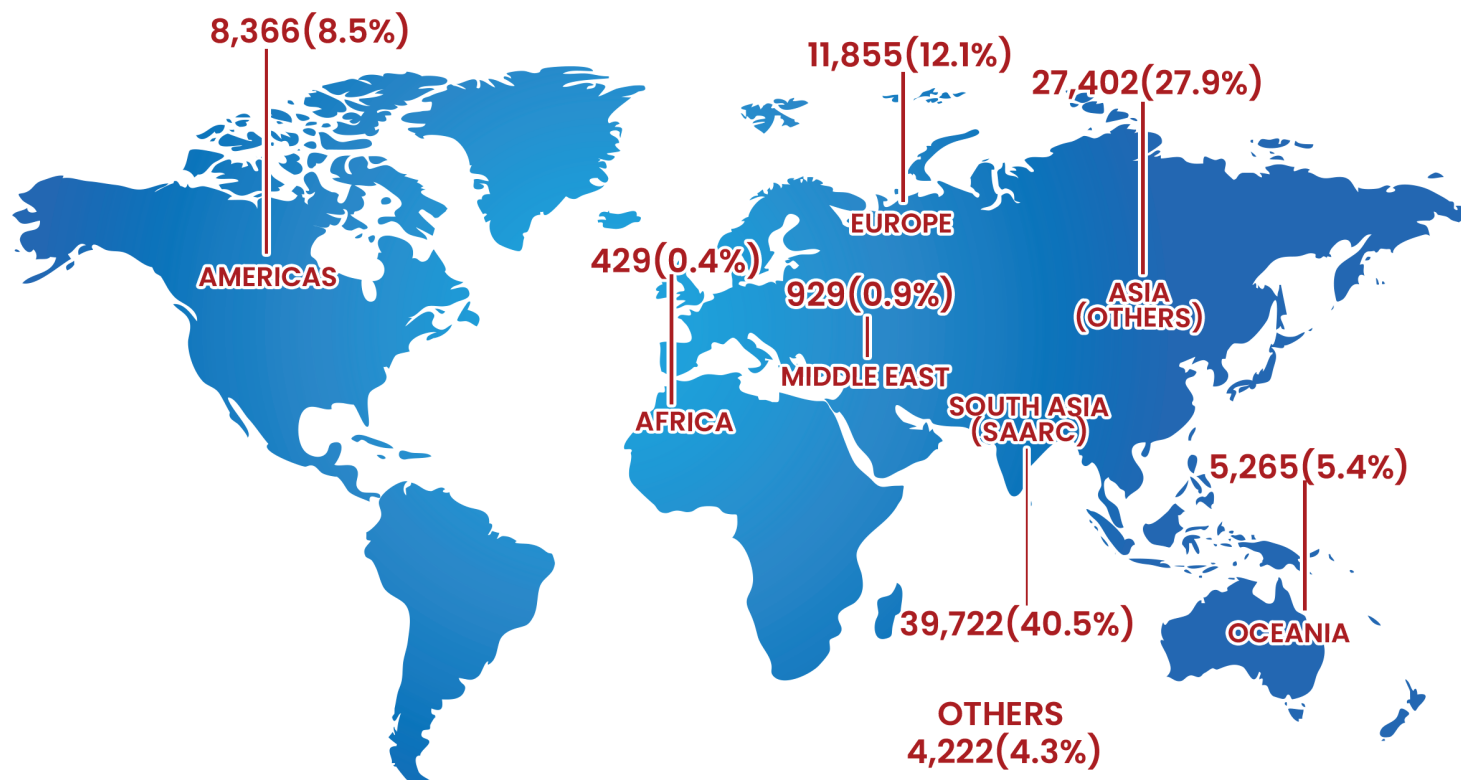

December 2025



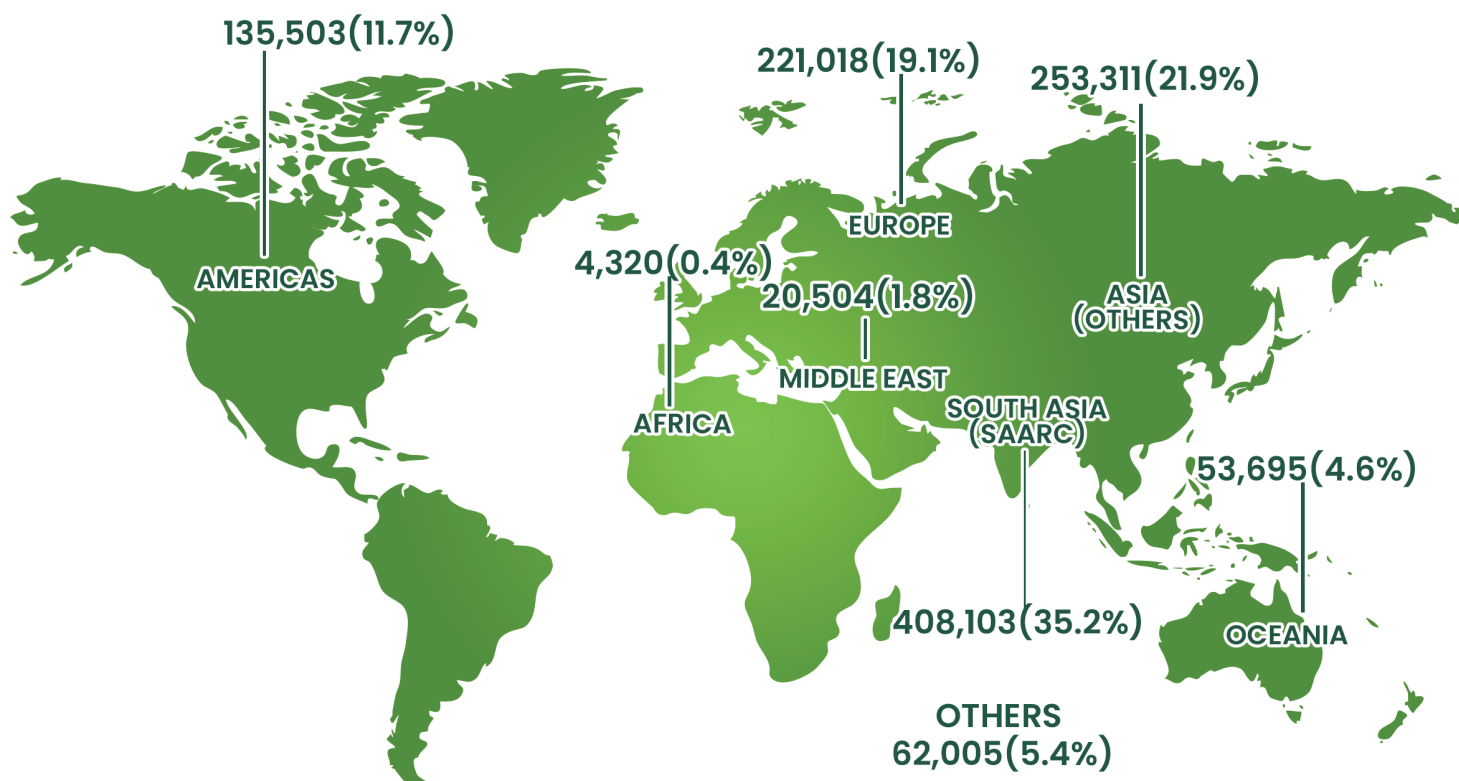

January - December 2025

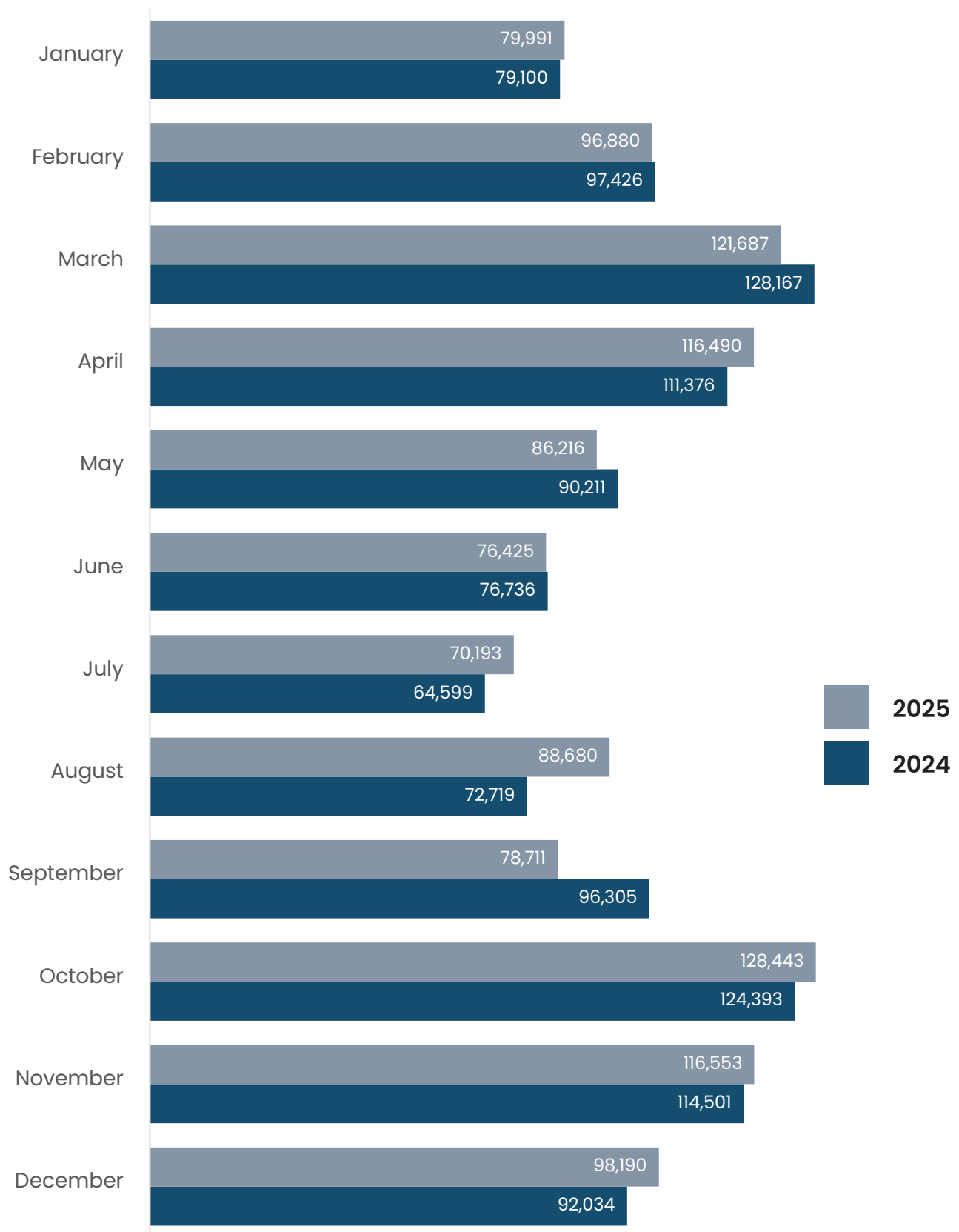

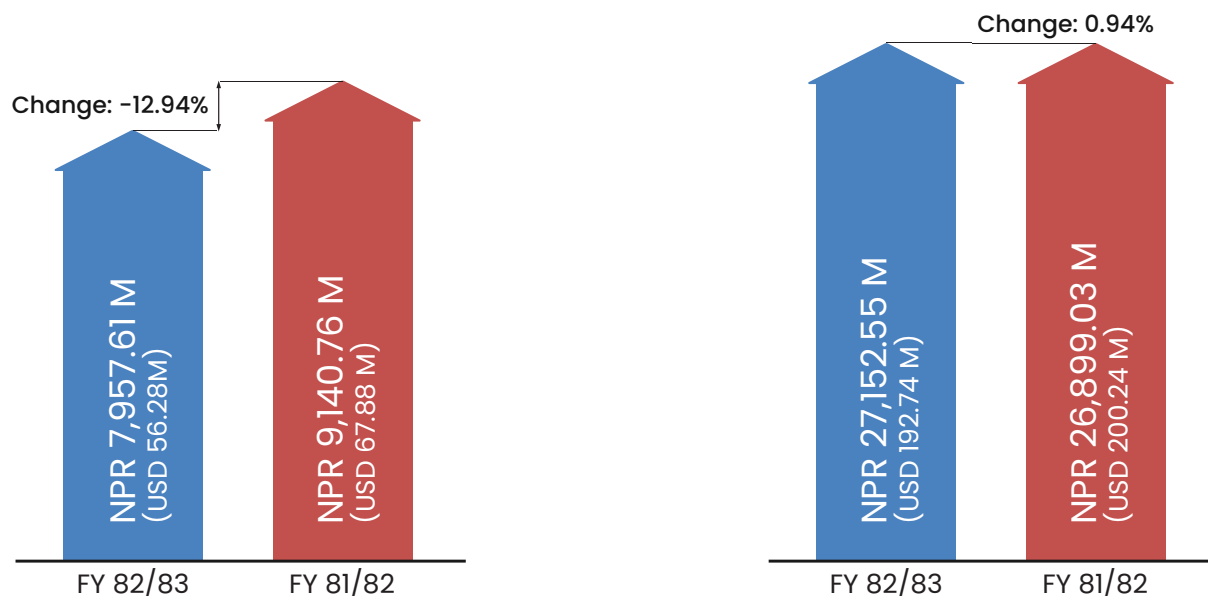

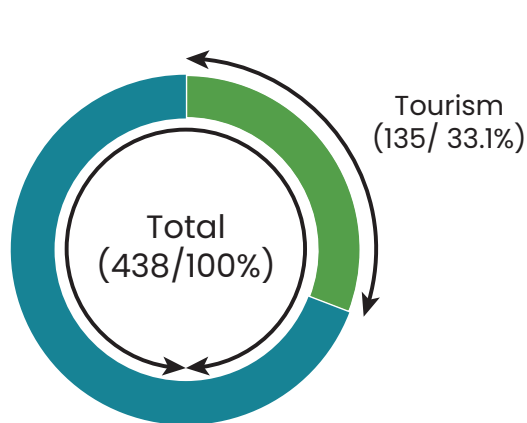

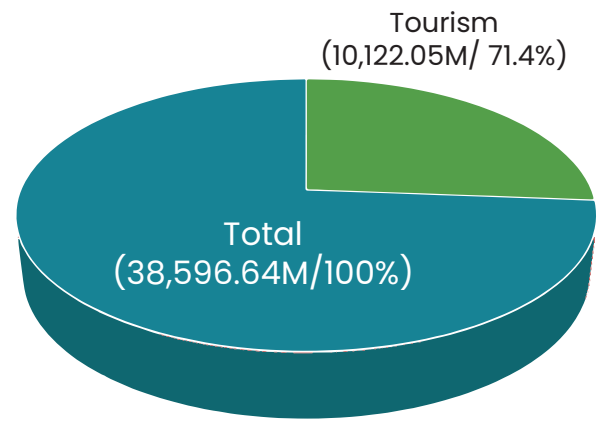

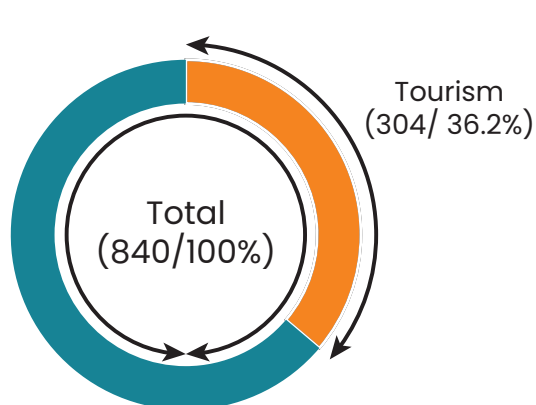

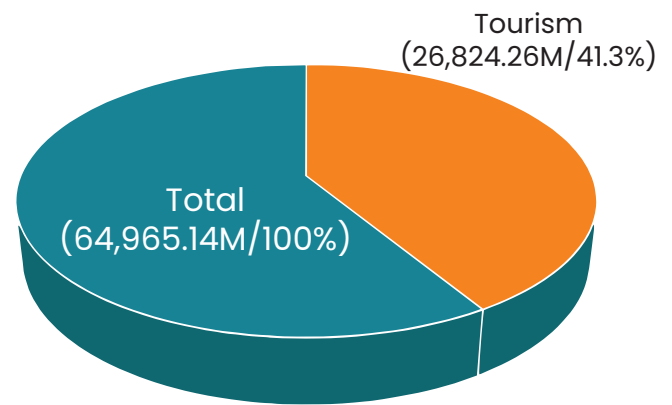

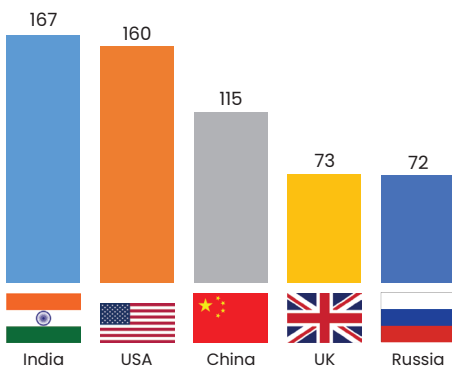

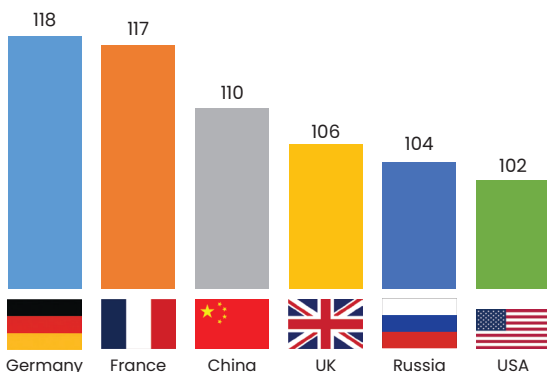

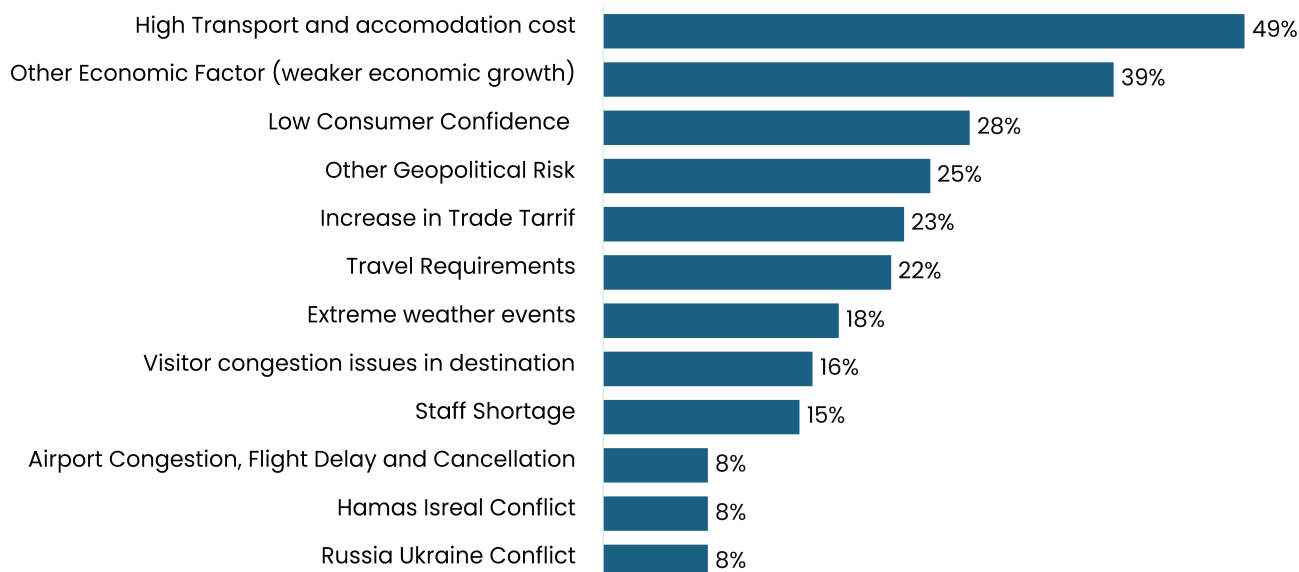

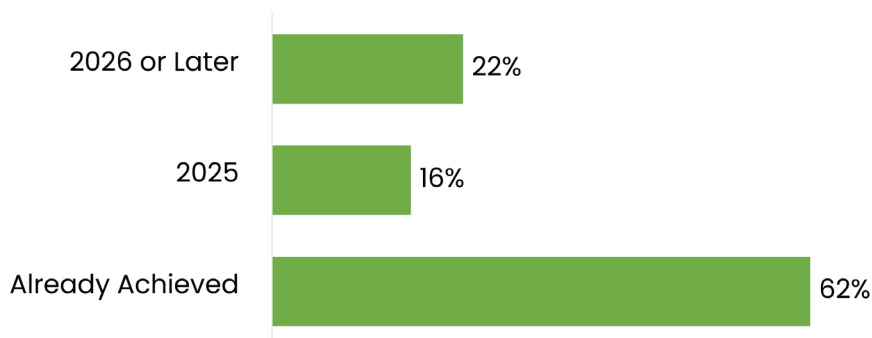


Global Tourism Context (UN Tourism Experts Survey*)

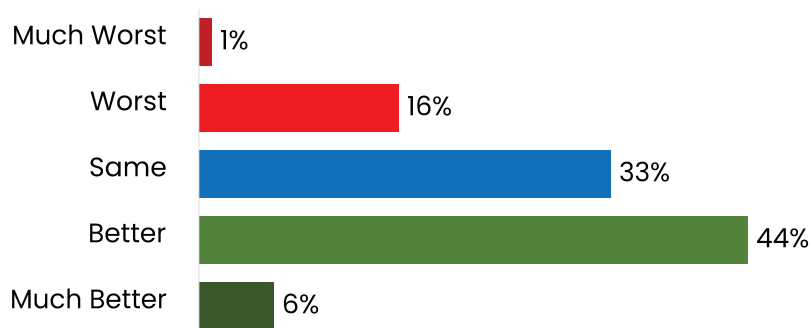
Factors Weighing International Tourism
