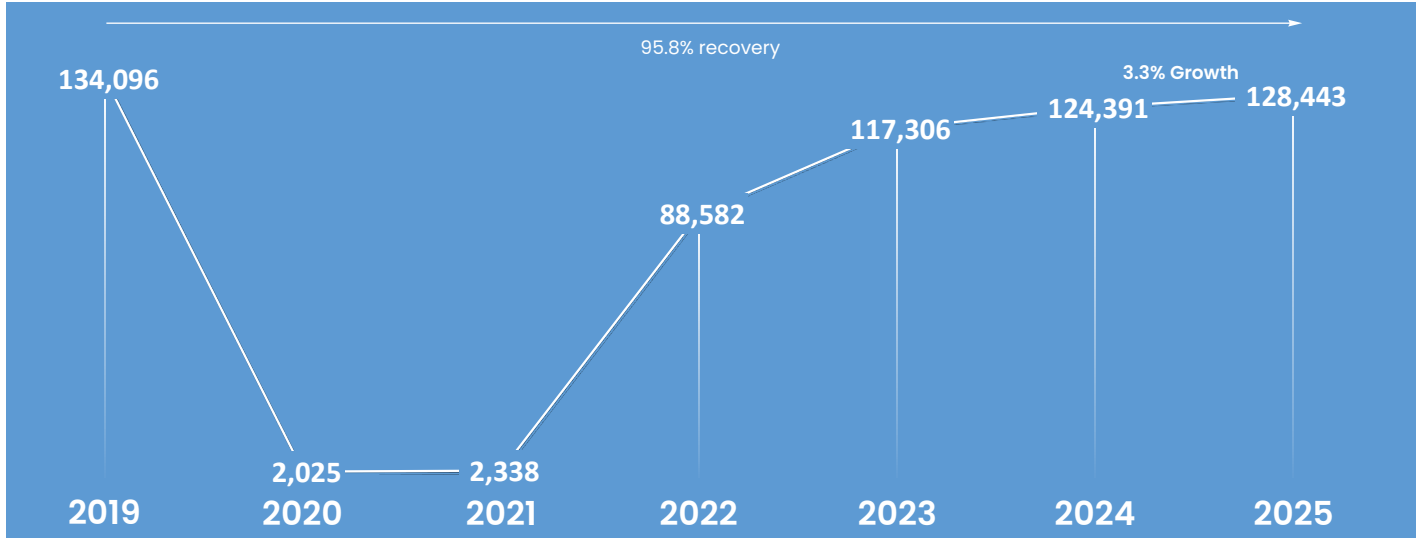

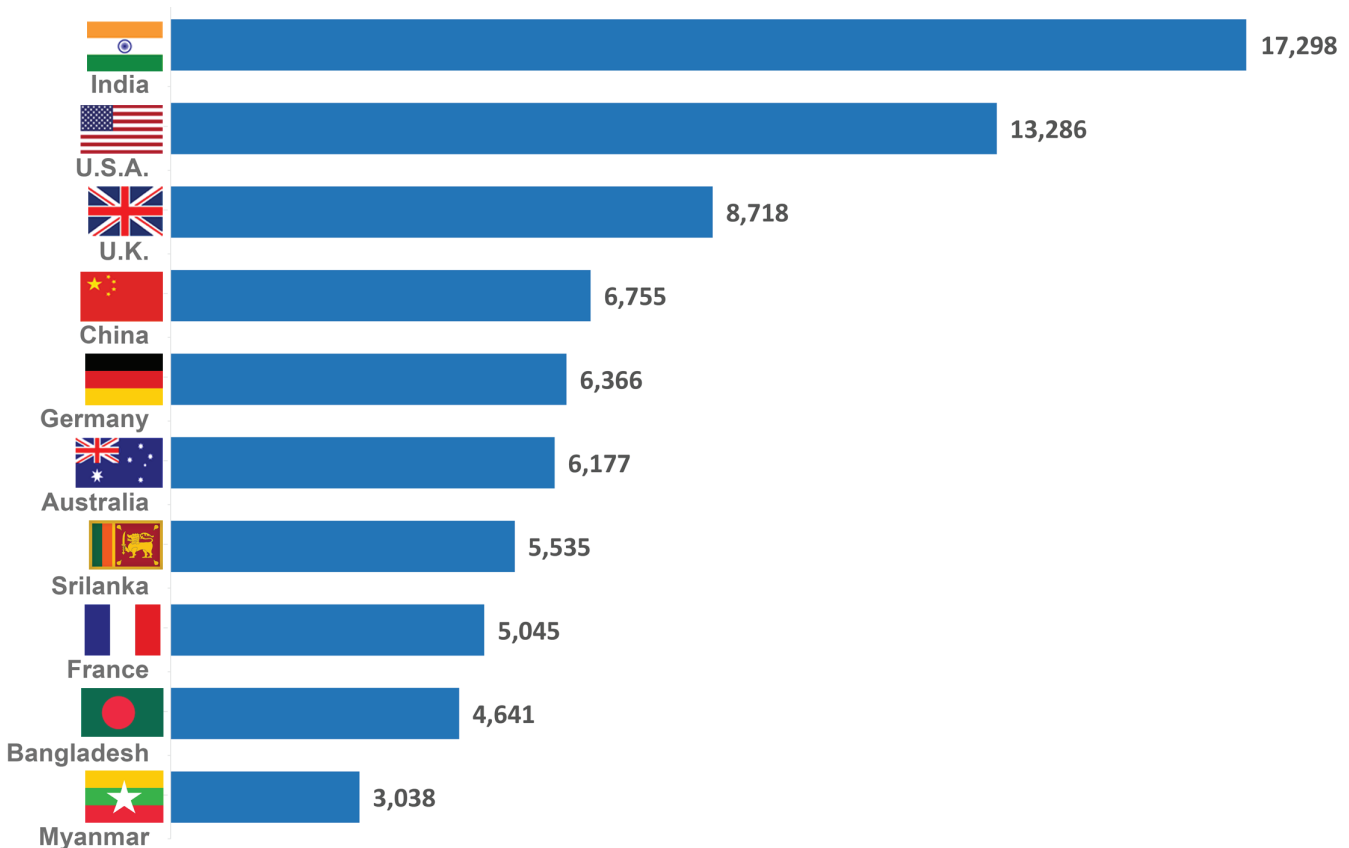

Top 10 Source Market Countries (OCTOBER)



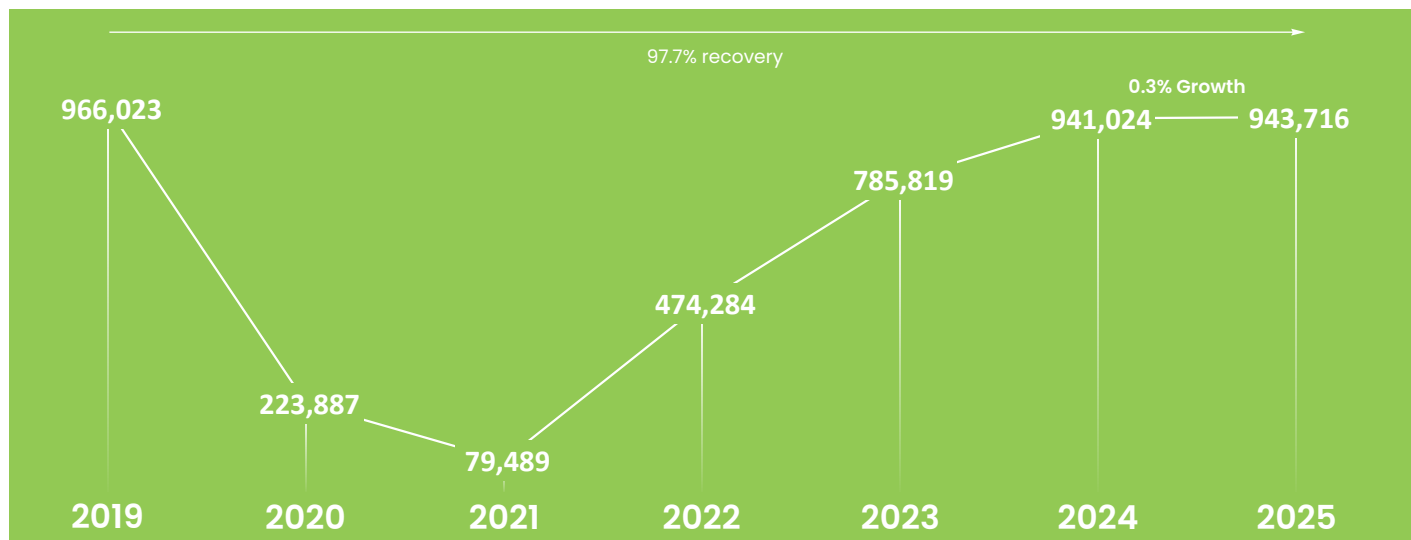

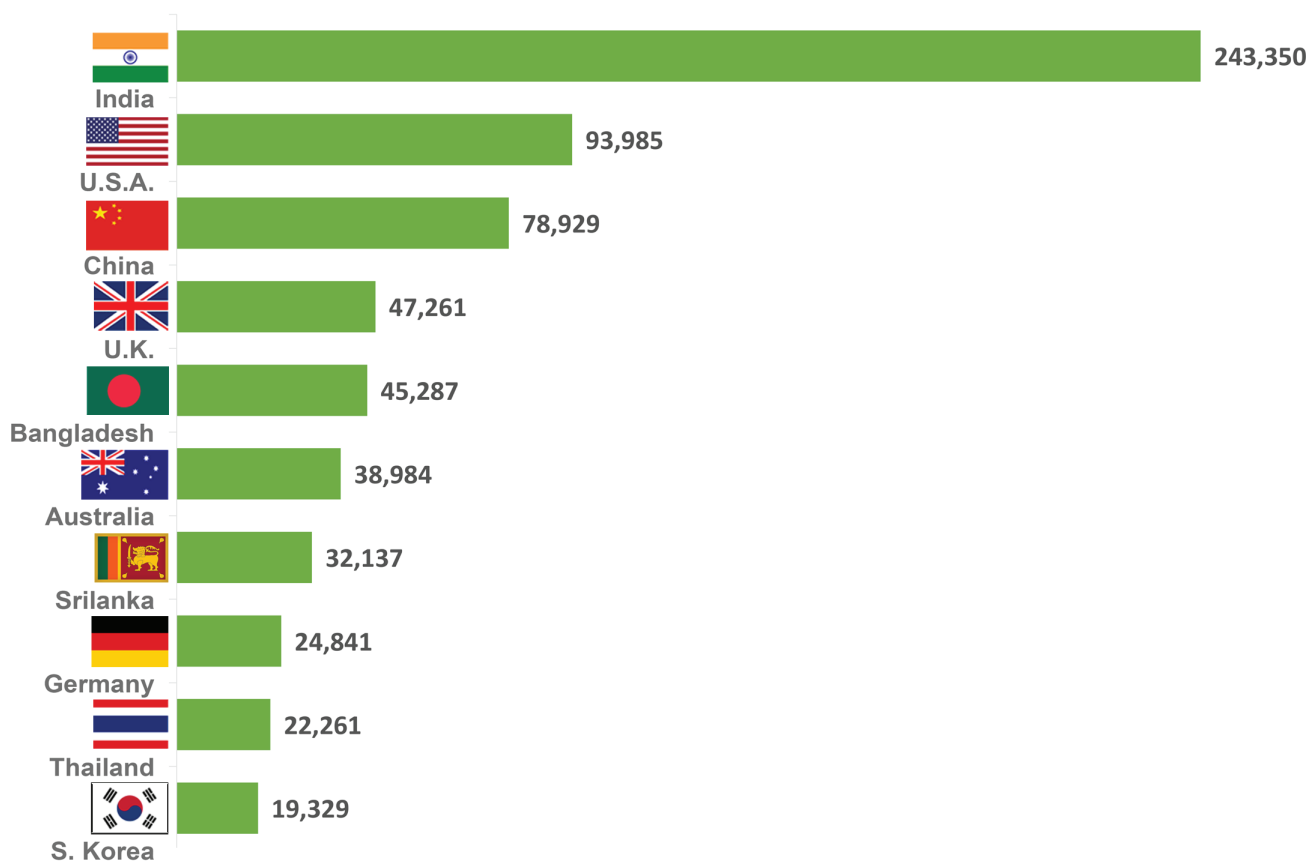

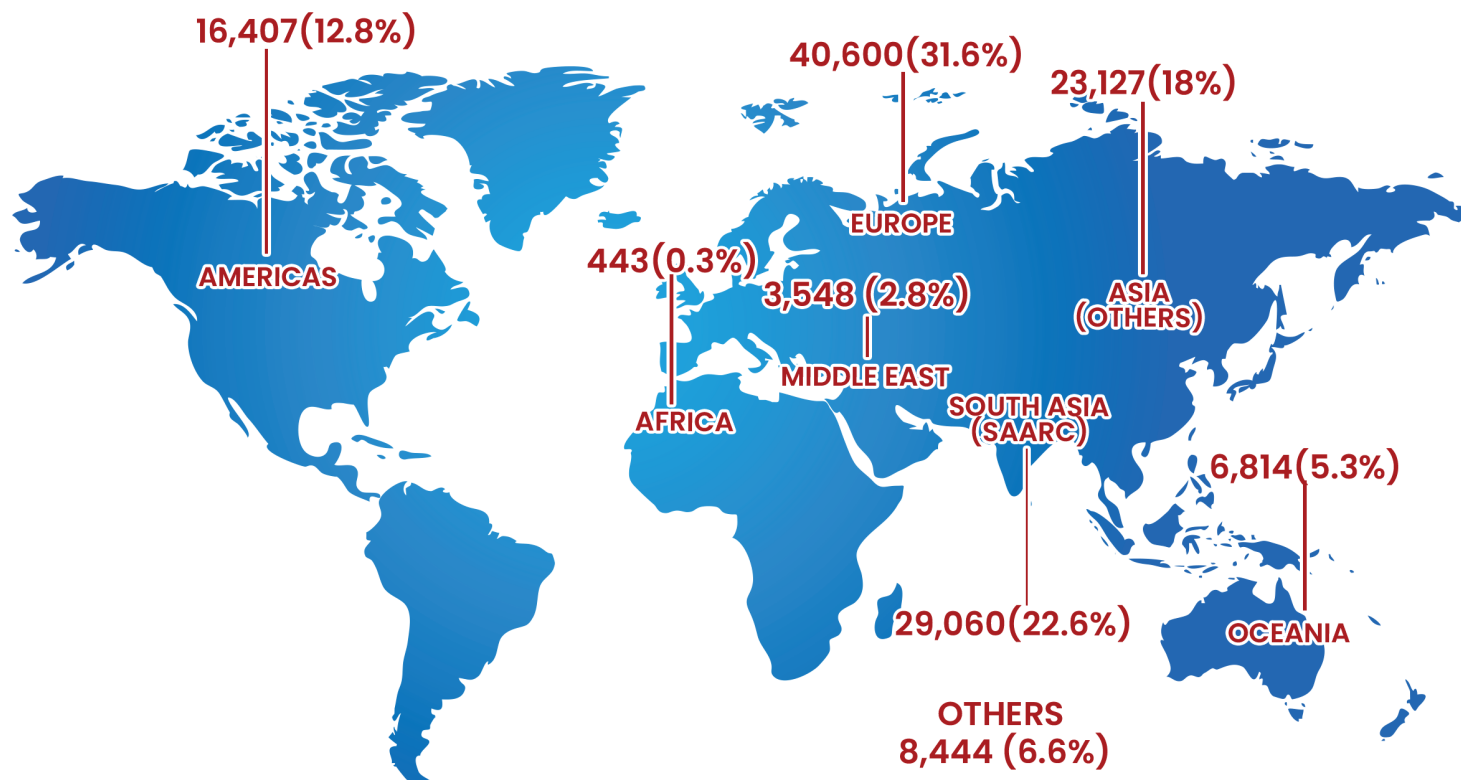

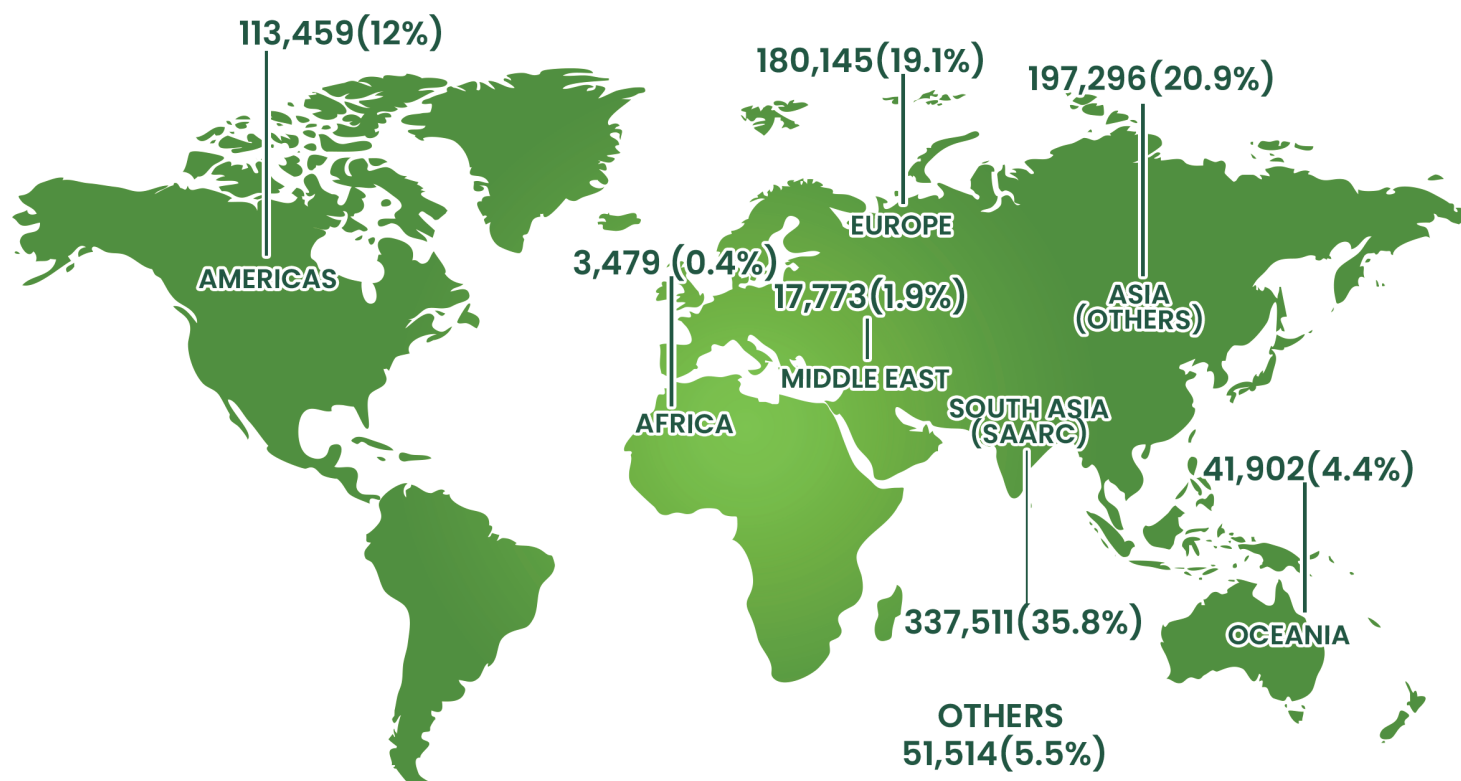

January - October 2025

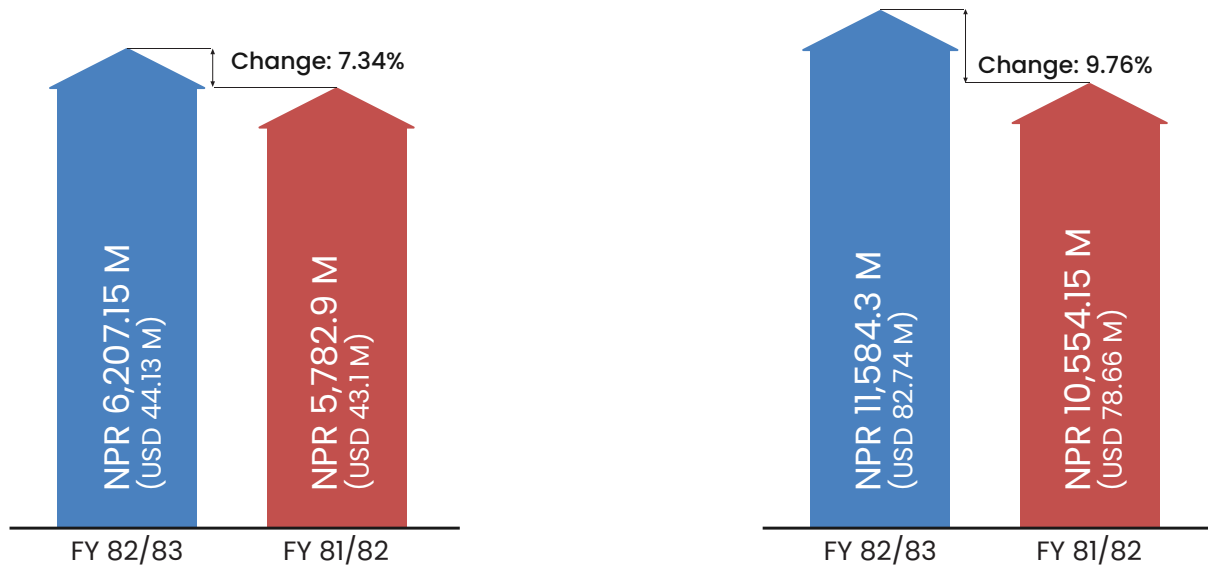

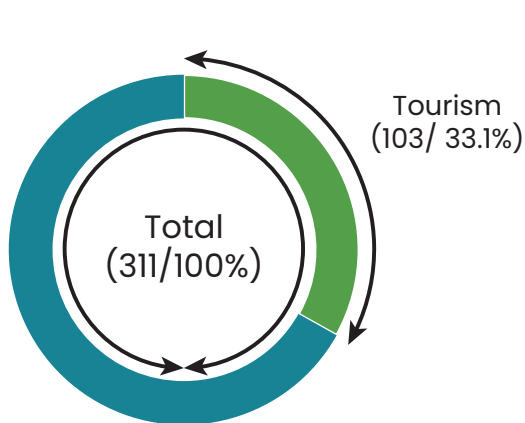

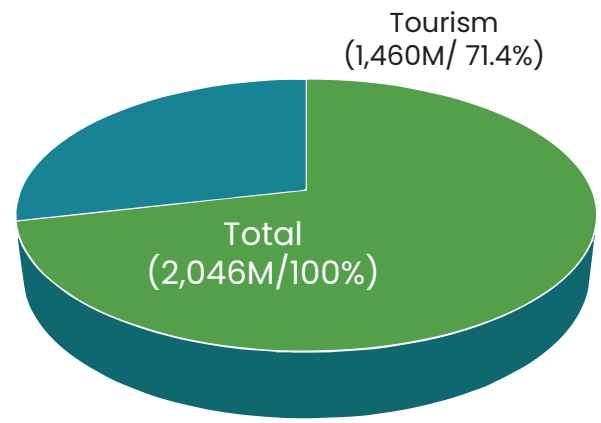

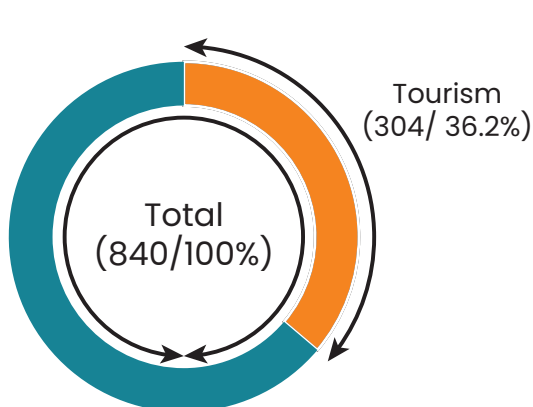

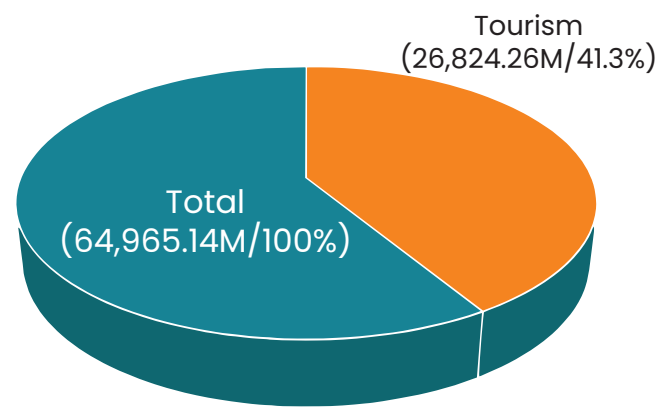

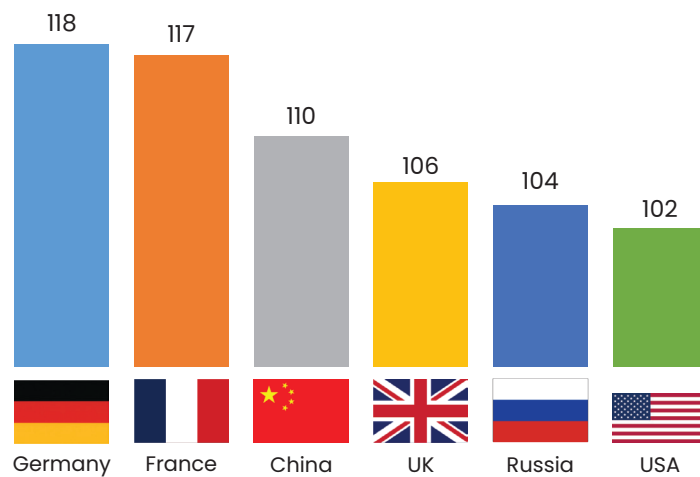

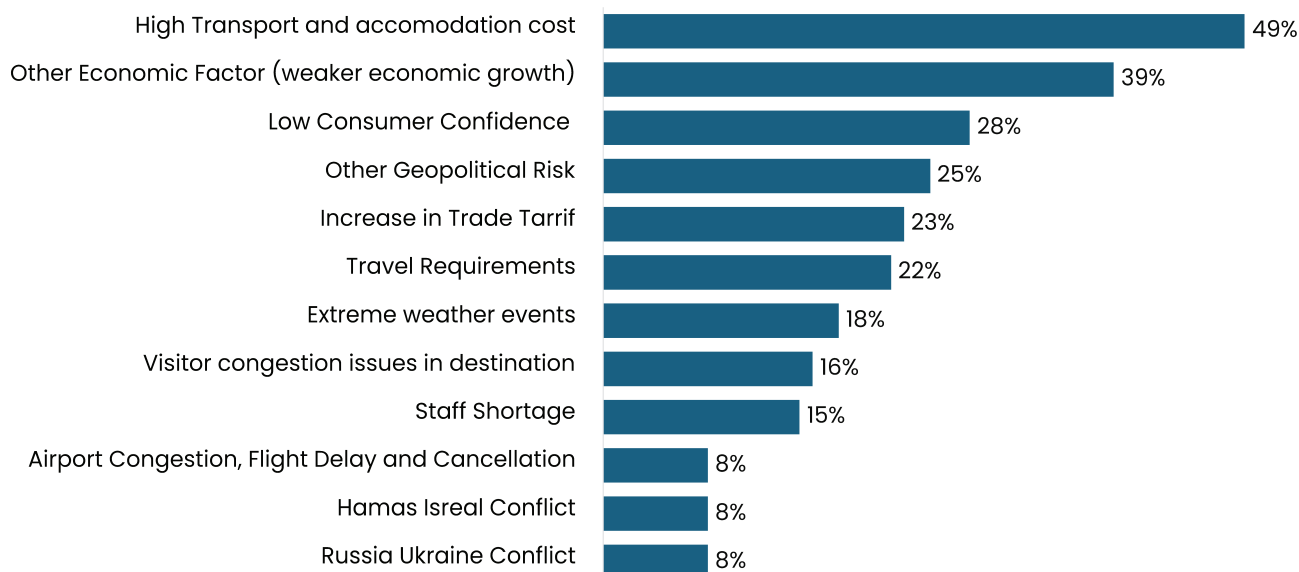

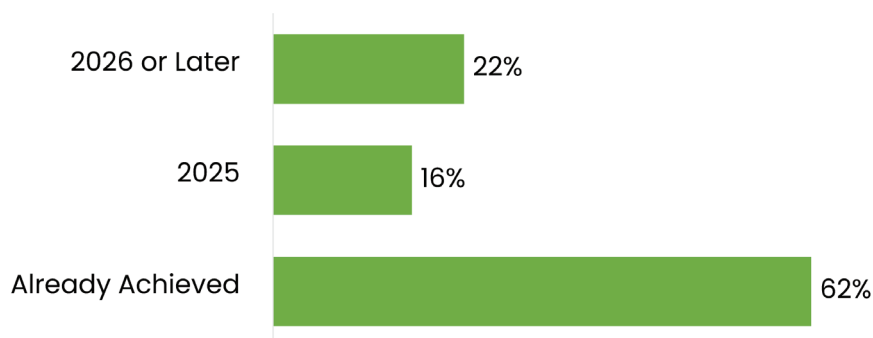

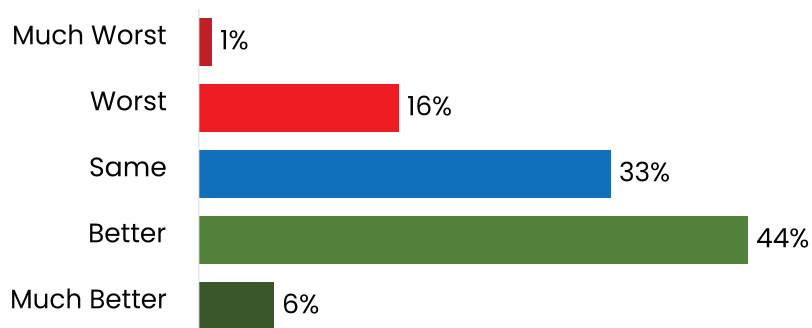
Factors Weighing International Tourism
