








- Foreign Exchange Earning from tourism in the month of Poush FY 81/82 (Dec-Jan 2025) was NPR 6,675.17 Millions which is 17% more in comparision to that of previous FY 80/81.
- Similarly, Cumulative Foreign Exchange Earning for the period of the first six months of FY 81/82 (Shrawan-Poush / Jul-Jan 2025) was NPR 41,860 Millions which is 5.12% more in comparision to the same period of previous FY 80/81.
