


INTERNATIONAL VISITOR ARRIVALS (IVAS) 121,687

Top 10 Source Market Countries (MARCH)










Region-wise Distribution of Arrivals





- Foreign Exchange Earning from tourism in the month of Falgun FY 81/82 (Feb-March 2025) was NPR 7,488.65 Millions which is 24.69% more in comparision to that of previous FY 80/81.
- Similarly, Cumulative Foreign Exchange Earning for the period of the first eight months of FY 81/82 (Shrawan-Falgun / Jul-March 2025) was NPR 56,703.28 Millions which is 9.70% more in comparision to the same period of previous FY 80/81.
