





Region-wise Distribution of Arrivals



- Foreign Exchange Earning from tourism in the month of Jestha FY 81/82 (May-June 2025) was NPR 6,492.69 Millions which is 9.2% less in comparision to that of previous FY 80/81.
- Similarly, Cumulative Foreign Exchange Earning for the period of the first eleven months of FY 81/82 (Shrawan-Jestha / July 2024-June 2025) was NPR 82,198.62 Millions which is 6.91% more in comparision to the same period of previous FY 80/81.
